2. Booth 20' x 20' space for \$45.00
3. Electricity is \$10 additional

(activity vendors may be granted additional space). Vendors must supply their own materials (canopies, tables, electrical cords, signs, etc.) and are responsible for all set-up and take-down. Vendors are required to stay in their assigned space and required to stay for the duration of the festival.

4. Payment must accompany application. Unapproved applications and payments will be returned to you.
5. Any vendor that has animals on-site (for display or adoption) or food vendors must provide a copy of their liability insurance. Accepted activity vendors (and those required vendors) must provide proof of insurance, by August 1st for one million (\$1,000,000) dollars naming the Lewis County Agricultural Society as additional insured.
6. Electricity is available on a limited basis (see below for fee structure). Payment must accompany application.
7. No refunds after the early application deadline of August 1st, 2019. Prior to the deadline, refund will be given less \$5.
